



Registration Instructions

Spring/Summer Registration will be held on April 5, 2008 in the Burnsville High School Cafeteria from 9:30-11:30. If you can not make Registration in person, all completed Registration forms with payment can be mailed to **Black Dog Swimming, PO Box 1022, Burnsville, MN 55337**. All completed forms and payments must be received on or before April 9. **NO SWIMMER WILL BE ALLOWED IN THE POOL WITHOUT A COMPLETED REGISTRATION AND PAYMENT.**

Novice Swimmer Instructions

- 1) **Complete one copy of the Registration Form – One per Swimmer**
- 2) **Complete MSI Seasonal Registration Form – One per Swimmer** (only required if swimmer did not file 2008 Full Season MSI Registration)
- 3) **Complete one copy of the Dues Worksheet – One per Family**
 - a) Calculate Current Dues Payable – Consult the Dues Schedule for proper amount and follow worksheet instructions.
 - b) Determine Checks Due at Registration – **Check** should include: Current Dues Payable; Any outstanding balance from prior seasons; MSI registration fee – One per Swimmer.:

Bronze, Silver (Tier 2 & 4), Gold and Platinum Swimmer Instructions

- 1) **Complete one copy of the Registration Form – One per Swimmer**
- 2) **Complete MSI Seasonal Registration Form – One per Swimmer** (only required if swimmer did not file 2008 Full Season MSI Registration)
- 3) **Complete one copy of the Dues Worksheet – One per Family**
 - a) Calculate Current Dues Payable – Consult the Dues Schedule for proper amount and follow worksheet instructions
 - b) Determine Checks Due at Registration – **Check #1** should include: Current dues payable, Any outstanding balance from prior seasons; MSI registration fee (one per swimmer, if applicable); Optional meet fee deposit; LESS 50% deferral of current dues if electing to pay in two installments. **Check #2** should include: Volunteer deposit of \$100. **Check #3** should include: 50% deferral of current dues if electing to pay in two installments; \$20 installment plan service charge. *Deferral payment checks should be postdated to June 1, 2008.*
- 4) **Sign up for volunteer positions at the volunteer table.**

Gold – Half Season, Gold Morning Fitness and College Instructions

- 1) **Complete one copy of the Registration Form – One per Swimmer**
- 2) **Complete MSI Seasonal Registration Form – One per Swimmer** (only required if swimmer did not file 2008 Full Season MSI Registration)
- 3) **Complete one copy of the Dues Worksheet – One per Family**
 - a) Calculate Current Dues Payable – Consult the Dues Schedule for proper amount and follow worksheet instructions
 - b) Determine Checks Due at Registration – **Check #1** should include: Current dues payable; Any outstanding balance from prior seasons; MSI registration fee (one per swimmer, if applicable); Optional meet fee deposit.
